Foreword

Inasmuch as we humans ultimately only have two choices to the future — "Peace or War" — in the face of unending nuclear weapons development, once nuclear war breaks out, the earth will turn into ashes. This indicates that peace is the life, the truth, and the way. The Charter for Permanent Peace is the way of protecting human rights, and the eternal road to life and truth. Without the Charter, the holy land for permanent peace and the truth will not be achieved together to live up to the genuine meaning of life.

Inasmuch as the Super Constitution originally invented by Taiwan to peacefully confront the "Transfinite War"/ "Unrestricted Warfare" of China shows the universal value of democracy and human rights to 4.6 billion Asians with no geographic and cultural barriers. This can be achieved through the traditional oriental concepts, "the World is for the People (from China) and Global Unity (from India)." Thus, we propose the Charter for Permanent Peace, the latest and greatest compass in the new century, for 249 political entities (including the 193 UN members). It adopts a wide-ranging democratic system vs. the oppressive autocracy system for eliminating endless military actions, promoting the halving of global military budgets, and converting swords into plowshares so as to prevent humans from suffering world hunger and poverty.

Inasmuch as democratic system is the ideal method to terminate despotism and unclear weapons. All disputes will ultimately be moved to an arena based on a democratic system where the pros and cons of its

system will be examined for a nation's rise or fall. Thus, we expect to import the world's best constitutions and laws into Taiwan, with advanced modification. Taiwan will have the best constitution and law in the world and export them to all other nations and states to provide humans a diverse and mutual democratic system for permanent peace.

Inasmuch as public participation is the core of democracy, we long for your support for Taiwan as the world's model of the Charter for Permanent Peace. Each petitioner will increase the effects of "chain reaction" and "dynamics of wave diffusion" to spark "justice" and shine on the "future" we want. As long as thousands and millions of people in the world sign the petition, quantitative change will definitely lead to qualitative changes. It will result in the peaceful evolution of Asian autocratic dictatorships without takings military actions.

Now, our global Permanent Peace Partners work together with Taiwan and the oppressed people in the world, standing in front of all humanity at this turning point in history, to support Taiwan as the model and declare that Taiwanese are global citizens, Taiwan's law shall become global law, and the Permanent Peace Constitution/ World Constitution standard is the latest and greatest demonstration for mankind to eliminate autocracies and wars. The declaration hereby offers a landmark document in the history of world peace, presenting a new and final system which supports all people and all countries implementing national constitutional standards and respecting international human rights. The Charter for Permanent Peace will be universally and effectively recognized and complied with among all people in the world.

Two Eternal Concepts of the Charter for Permanent Peace

- Permanent Peace: Innovate Global Governance, Demonstrate One Law for All, Construct a Common Constitution Applicable Throughout the World.
- **2. Sustainable Development:** Develop Constitutional Standards, Lead to World Community of Nations, March Toward Global Unity.

28 Basic Principles of the Charter for Permanent Peace

Section One

Permanent Peace – the Foundation for Free Nations

- 1. National Freedom Standards: The state has a duty to ensure human dignity and freedom that surpass those of other nations; that all laws to guarantee freedom constitute a part of domestic law, and that the people have the right to choose the best way to protect universal values.
- **2. Human Rights Standards:** Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.
- **3. Voting Frequency Standards:** This is necessary to ensure frequent voting for humanity dignity, values, freedom, human rights, justice, peace and sovereignty at least two elections per year.

4. Election Procedures Standards: Money politics —Election expenditures by candidates are strictly forbidden. All TV stations shall reserve at least 60 minutes per week to broadcast each candidate's policies for free, and radio stations and internet media shall provide double that amount of time

Section Two

Permanent Peace – Standards for Democratic Nations

- **5. National Democracy Standards:** National sovereignty is unconditionally and comprehensively held by every taxpayer. The right to draft and amend the constitution belongs only to the people, and state organs and civil servants must not interfere.
- **6. Global Democracy Standards:** In support of global governance and popular sovereignty, elites around the world are recruited to enhance national competitiveness and spearhead the world unity. Citizens of fully-democratic countries are allowed to stand for election as officials of state at all levels in accordance with the law.
- **7. Term of Office Standards:** Any elected government head shall serve one five-year term, and he/she and close relatives shall not be eligible to run for office for six years after leaving office. During this period, salaries and benefits may not be adjusted.
- **8. Associations' Responsible Standards:** Abuse of freedom of association to undermine the concepts of law, international law, the Constitution for permanent peace or international understanding is prohibited.
- **9. Democracy Defense Standards:** Anyone who intends to harm, abolish or attack freedom and democratic order shall be immediately sanctioned

by law. Those who have democratic rights must be entitled the duties – mandatory voting in elections.

Section Three

Permanent Peace – Human Rights Standards for Nations

- 10. Human Rights Standards: Promoting permanent peace is the most sacred human rights and most urgent obligation in all nations in order to build life values, develop constitutional standards and improve resource allocation.
- 11. Global Human Rights Standards: Constitutional standards guarantee human rights standards, and human rights issues are of global internal significance; violations of one's human rights shall be treated as violations of human rights of all human beings.
- **12. National Decentralization Standards:** The administrative, prosecutorial and justice heads are elected by the people every year to ensure that human rights are not infringed; a quarter of all legislators will be reviewed and reelected by voters each year.
- **13. Constitutional Guarantee Standards:** The President, representatives of public opinion, administrative officers, judges, military officers, and other public officials are all constitutional guaranters who must be loyal to taxpayers.
- 14. Human Rights Organization Standards: Human rights take precedence over sovereignty to build a community for human destiny; half of the members of the Committee for Human Rights and the Exercise of Citizenship Rights shall be appointed by international human rights organizations.

Section Four

Permanent Peace - Standards for Rule of Law

- **15. National Rule of Law Standards:** The latest and greatest political system will lead mankind. Legislative, administrative, judicial and global cooperation is an eternal obligation that shall not be omitted or excluded.
- **16. Rule of Law Belief Standards:** Human rights, constitutionalism, international legalism, and global (democratic multi-common) law shall be beneficial credos for all nations. (See Freedom of Personal Belief-1.)
- 17. Legal Hierarchy of National Law Standards: International law takes precedence over domestic law with direct bearing on the rights and duties of the people to ensure permanent peace in One World under One Set of Laws.
- **18. Standards for All Laws in One:** The laws of all nations that have universal values will be folded into domestic law, and people can choose the laws best suited to their needs. State organs have the right of refusal but must state their reasons.

Section Five

Permanent Peace – Legislative Development Standards

19. Central Legislation Standards: Legislature adopts Committee-centric system to practice 12 Standing Committee, 12 congresses and 12 shadow governments for effectively increasing national strength by 12 times.

- **20. Local Legislation Standards:** The term of representatives of the people shall be two years to ensure that the public opinions at communities are conveyed directly to the international levels. Voters may observe and participate in deliberations in legislative bodies at all levels according to law with no voting rights.
- 21. Law Comparison Standards: The standards to promote global cooperation in legislation in a nation shall maintain a complete database comparing laws and regulations around the world so that everyone in legislative, administrative and judicial agencies can master the latest regulations, and citizens of the world can compare and use the latest global regulations.

Section Six

Permanent Peace – Administrative Development Standards

- **22. National Central Administrative Standards:** The President and the Prime Minister, who must be native-born and responsive to their public opinion base, shall be directly elected by the people to support the Semi-presidential Cabinet System. The Prime Minister is in charge of daily government operations as well as national defense.
- **23. International Administration Standards:** In order to promote global cooperation, the state will make at least 5% of its military personnel and arms available for assignment with global organizations to carry out international security and peace missions.
- **24. Sovereignty Authorization Standards:** The consent of 3/4 of all citizens is required to withdraw the state from international peace and mutual protection systems or to enter a treaty with a single nation; but withdrawal requires the consent of 1/2 of all citizens.

Section Seven

Permanent Peace - Law and Prosecution Standards under

- **25. Independent prosecution standards:** Director of Public Prosecutions shall be directly elected by the people. Judicial reforms shall be proposed and carried out by elected department heads; the director and deputy director of local prosecution must be elected according to the ranking of result in elections.
- **26. Judicial Decision Prediction:** People are free to inquire their own legal status ubiquitously to develop a national/global system for forecasting judges' decisions with a reliability of more than 2/3 to meet needs for accuracy.

Section Eight

Permanent Peace – Law and Justice Standards

- 27. Standards for Judicial Rulings: All laws in one must be implemented to ensure permanent peace and justice will always be responsive. Half of the Justices of Constitutional Court shall come from various continents and be of different nationalities.
- **28. Constitutional Review Standards**: Global Agreement on the Constitution and Global Review of Unconstitutional Actions will help prevent violations of international law or the Constitution. When no immediate remedy is available, all people have the right to resist.

Every provision in this Charter is based on the principle of Permanent Peace. It is the ultimate system for humanity (Permanent Law/ Global Law) that establishes a great cause for the country, builds great love for mankind, establishes Great Law for heaven and earth and is equally

useful for all nations. It means an end to the chaos of the old times and the beginning of peaceful development in a new era.

For the people of Taiwan and those under oppression, this charter is all about justice and every item is a savior. For authoritarian dictators, its words are a natural enemy and the sentences are all their nemeses. Sovereignty lies in the hands of the people under the Super constitution. On the other hand, no matter how it may change, it will always be better than the earth-shaking changes that follow the Communist Party of China's (CPC) authoritarian totalitarianism

For the Permanent Peace Partnership World Association, everyone supporting this Charter is a guardian of peace directly tied to God's will. Supporting Taiwanese People -World People, Taiwan Law-Global Law, the Taiwan Model for Permanent Peace and Law, as well as the globalization of Taiwan, global cooperation to safeguard national sovereignty and development, Taiwanization of the world, peaceful evolution of Asian dictatorships, the elimination of totalitarian regimes backed by nuclear weapons and the construction of a permanent human civilization.

To this end, the people of Taiwan and the other 2/3 of the world's civilians suffering under dictatorships around the world have nothing to lose but their iron curtains and walls and the violence and lies that constrain them. Instead, others will gain prosperity, happiness, truth, goodness and beauty. Everyone will find self-fulfillment, with every family living and working in peace and contentment under the world capital prosperity.

Finally, the broad scope of this Constitution and its far-reaching implications, particularly in transformation of the world's permanent peace and development, the general population cannot easily be integrated, which may hamper development of constitutional enthusiasm among the people. Only when international organizations with global reach or impact on regional security, the legislative bodies of democratic countries, and the majority of Nobel Peace Prize winners are willing to take the lead in supporting this movement, will we have an opportunity to achieve permanent peace on a political entity-by-political entity basis.

本憲章任一條款都是以永久和平為要素,都是在為本國立大業、為人類立大愛、為天地立大法、為萬國立大同的人類最後體制(永恆法/世界法);代表舊時代內亂外患的終結、新時代和平發展的開端。

本憲章對台灣及被壓迫者來說,條條都是正義、項項都是救星;對專制獨裁者而言,字字都是天敵、句句都是剋星;對任何人而言,無論如何改變,絕對優於被-中共-專制極權統治後翻天覆地的改變。

本憲章對全球永久和平夥伴而言,人人都是與天意連線的和平天 使。支持台灣人-世界人、台灣法-世界法、台灣示範永久和平法; 台灣全球化,全球共同攜手維護國家主權與發展;全球台灣化,和平 演變亞洲獨裁專制,滅絕極權核武,建構人類永恆的文明體制。

第四單元 永久和平 - 法治立國基準

- **15. 法治立國基準**: 建構人類永恆的體制: 全球性競合立法權, 行政權, 司法權是國家不得免除、不得變更的永恆義務。
- **16. 法治信仰基準**:人權主義、憲法主義、國際法主義、世界(民主多元共同)法主義為人人有利無人受害的國家信條。
- **17. 萬法法階基準**:保障永久和平,一個地球一套世界(多元共同)法; 國際法高於國內法,直接對人民發生權利義務。
- **18. 萬法歸一基準**: 建構世界法, 萬國萬法構成國內法的一部分, 普世價值的法律, 人民得擇優援用、法院得依法審判。

第五單元 永久和平 - 立法發展基準

- **19. 國家立法基準**: 國會採委員會中心主義制 --- 示範 12 個常設委員會 = 12 個國會 = 12 個影子政府 = 12 倍速提升國力。
- **20. 地方立法基準**:確保社區民意直達國際,民代任期兩年 --- 選民皆 得依法參與各級議會審議,但無表決權。
- 21. 萬國比較基準:推進立法全球競合。國會設完整的萬法比較資料庫,讓地球公民皆可比較與援用最新全球法規。

第六單元 永久和平 - 行政發展基準

- **22. 國家行政基準**:半總統內閣委員制 --- 總統民選;總理 部長須本 土出生,有民意基礎;總理指揮政府、掌理國防。
- **23. 國際行政基準**:推進行政全球競合。國家至少派遣 5% 軍隊軍備, 配屬全球性組織,執行國際安全與和平任務。
- **24. 主權托付基準**:國家退出國際和平互保體系須經 3/4 公民同意;加入單一國體須 3/4 公民同意,退出須 1/2 同意。

第七單元 永久和平 - 司法檢察基準

25. 檢察獨立基準:檢察院長民選。司法改革由當選人提出及執行;

永久和平憲章二項永恆理念

- 1. 永久和平: 創新全球治理,示範萬法歸一,建構世界共同法。
- 2. 永續發展: 創造憲法基準, 引領萬國大同, 推進世界一公國。

永久和平憲章二十八項基本主張

第一單元 永久和平 - 自由立國基準

- 1. **自由立國基準**:國家有義務確保人的尊嚴,自由不落後他國一天; 人民有權利擇優援用萬國萬法以保障普世價值。
- **2. 自由天賦基準**:國家不得設立宗教或禁止信教;限制或削奪人民言 論出版;削奪人民和平集會及請願救濟之法令。
- 3. **投票頻率基準**:確保提升人性尊嚴、價值、自由、民主、人權、與 正義的選舉及公投頻率 --- 每年至少二次機會。
- **4. 選舉程序基準**:嚴禁選舉花錢。電視台每年每週至少 60 分鐘免費 供選務機關應用。網路及無線電台至少加倍供應。

第二單元 永久和平-民主立國基準

- 5. **民主立國基準**:國家主權無條件全面屬於納税人全體。制憲修憲的權利只屬於人民,國家機關及公務員不得干涉。
- **6. 普世民主基準**:全球治理、主權在民,菁英昇華國力、引領人類大同,完全民主國家公民得依法參選我國各級首長。
- 7. 首長任期基準:任何民選首長一任至長五年,不得修改;任滿六年 內本人及至親依法不得再選;此期間待遇不變。
- **8. 結社責任基準**:禁止濫用結社自由,宣傳牴觸法律、國際法、永久 和平憲法、世界(共同)法或國際諒解之思想。
- 9. **防衛民主基準**:凡意圖損害、廢除或攻擊自由民主秩序者,應受法 律制裁。民主人人有權有責 - 民代選舉須強制投票。

第三單元 永久和平 - 人權立國基準

- 10. 人權立國基準: 創造生命價值, 催生憲法標準, 改進資源分配, 推 進永久和平是人民最神聖的權利-是國家最緊急的 義務。
- 11. 人權普世基準:憲法標準保障人權標準,人權問題是全球內政; 侵犯任何一個人權,視同侵犯全體人類的人權。
- 12. 國家分權基準:確保人權不受侵犯 --- 行政、檢察、審判首長分年

鑑於我們人類 "最後" 只有兩條路:和平或毀滅。面對無窮盡的核 武發展,一旦核戰,萬物皆灰;足證和平就是生命、就是真理、就是 道路。永久和平憲章就是人類永恆的生命真理之路;若不藉著本憲章, 無人能到達永久和平聖地,與真理生活在一起,實踐生活真諦;

鑑於滅絕專制核武不能靠核武,而是要靠制度,「任何戰鬥,最後都要回到『制度表現』這個戰場進行,在這裡驗證制度的良窳,決定社稷治亂興替」,為此,我們必須做到,過去-世界最好的憲法及法律都流入台灣,未來-全球最好的憲法及法律都從台灣流出,提供萬國萬邦(州)永久和平必要的、最後的世界(多元共同)法制體系;

鑑於中國民主化是世界和平的關鍵,只有台灣這套「超憲法」能和平演變中共的「超限戰」,因無地理文化隔閡,可向 46 億亞洲人證明民主人權的普世價值,可在東方傳統的「天下為公(中國)-世界一家(印度)」實現;為此,我們提出創新世紀的《永久和平憲章》,提供全球 249 個政治實體(含聯合國 193 會員國)一個新羅盤,採用廣納式民主制度 V. 壓榨式專制體制,一舉消弭無窮盡的軍事競賽,推動全球軍費預算減半,鑄劍為犁,消滅人類貧窮、普渡一切苦厄;
